#### a. National Weather Service - Pendleton

Mark Austin introduced himself and briefed the LEPC on what NWS has the capability of providing and what the agency can do during emergencies. He also included an overview of where NWS is as a federal agency. Additionally, Mark discussed the capabilities of the new Weather Service Satellite - GO 17 that was launched and its capabilities particularly when tracking fires.

#### b. Approval of Emergency Support Function 10

- Sean Davis briefed the FC LEPC on ESF 10 and stated that there were no major changes to the document and asked the FC LEPC if any changes were needed none were suggested. Mylan Muhlestein asked the FC LEPC for a vote to approve ESF 10 as it currently is written. FC LEPC unanimously approved.

b. Department of Corrections - Coyote Ridge - Gregg Miller and Andrew Sawyer Discussed their Full Scale Exercise scheduled for 2019 as well as their All Hazards IMT and mobile repeater.

#### c. Strategic National Stockpile and DOH

Rick Edwards reported on B/F Health's Functional Exercise scheduled for the end of April to receive the SNS - POD. The REDI Coalition is preparing for a patient surge exercise for eastern Washington. The CDC is reporting the potential for a bad flu season again, and is encouraging people to get their flu shots.d

#### d. Pasco Airport TTX

David Clark briefed the LEPC on the table top exercise that the Port conducted and state a Full Scale Exercise will take place in the fall.

e. SERC Briefing

Chief Harris briefed the LEPC that Chief Whealan has stepped down as the Chair of the SERC and will be replaced by Spokane Chief Schaffer. Rural HAZMAT is a hot topic on the SERCs agenda. Fire District #3 conducted a site visit at Lamb Weston over Thanksgiving and he encourages all the industry agencies to reach out to their local fire agencies and schedule up a walk through.

#### f. Lourdes Medical and Kadlec

Beki Hammons reported that Kadlec has changed out a bunch of their chemical cartridges that were purchased back in the CSEPP days. Justin Ratcliffe briefed the LEPC on Lourde's active shooter table top exercise.
