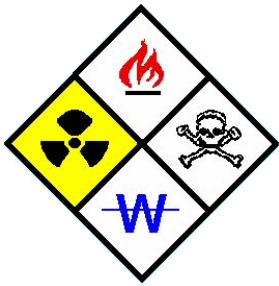

Franklin County LEPC Meeting Minutes December 5, 2017

Call to Order

Mylan Muhleston brought the meeting to order at 10:30 a.m.

Introductions

Approval of Board Minutes from September 9, 2017

Motion to approve the minutes was made by Rick Edwards with John Sherman seconding the motion – approved unanimously.

New Business

- **National Weather Service-Pendleton – 2018 Outlook – Dennis Hull**
A weak La Nina was issued by the Climate Prediction Center. They predict December – February will be colder than average with a chance of higher precipitation. Currently there are weather briefings held on Monday and Thursday. For those who would like access to those meetings, contact Dennis Hull at Dennis.Hull@noaa.gov (include your name, the company you work for, your position, email, and phone number).
- **ESF 10a comments / review and approval: Sean Davis**
ESF 10a was approved as is with nine criteria being met with six minor changes to be made in the future. Thanks to Kent Catlin for his help with the document.
- **Reported Spills / Leaks: Sean Davis / Mike Sheehan / Nicole Bolt**
Remember to make your required calls to EPA, local fire, and the LEPC (FCEM)
 - 08/17//2017, BNSF – Train versus Trespasser incident – There have been two fatalities (one at the Columbia River, one in the Kamiakin area).
 - 08/22/2017, USACE LOMO – 10gal oil into Snake River was reported.
 - 09/05/2017, USACE LOMO – turbine oil was reported in the Kahlotus/Snake River area.
 - 10/18/2017, BNSF – Sulfuric Acid residue was found on seven cars by a Hazmat Inspector and was cleaned up by the NRC. BNSF reported the incident.
 - 10/26/2017, BNSF – 2gal Diesel was bound leaking around a fuel gauge. BNSF reported the incident.
 - 11/02/2017, USACE LOMO – turbine oil at the Kahlotus/Snake River area was reported.
- **EPA Site Visits / Inspections week of Sept. 11-15, 2017 – Sean Davis / Jacque Cook**
EPA at the Butterfield and Douglas Fruit sites were going through procedures, checking for quantities in and out to make sure they matched, and looking at the physical sites for tags on valves, etc., to make sure they had proper documentation. EPA is also beginning to return to regulating dairy farms.
 - Butterfield Treatment Plant: Jacque Cook went to the Butterfield EPA

Inspection. There were some questions, which could not be answered due to staff not available. There was to be follow up.

- Douglas Fruit: Jacque Cook went to the Douglas Fruit EPA Inspection. Staff on site were available to answer questions and provide documentation for the EPA.
- Two Rivers Terminal: No one there to report.
- R.E. Powell / Christensen Inc. – EPA Propane Inspection went well.
- The Hanford Site is shrinking due to the cleanup process. In 2018, Section 5 will shrink while sections 6 and 7 will no longer be needed.
- It was suggested that LEPC stakeholders keep fire in the loop with site visits and with changes in procedures for everyone's safety.

Round Table

- **South Columbia Irrigation District – Mylan Muhleston**
 - The site is safest during winter months due to lack of hazardous product on site. A new building was built to house hazardous chemicals.
 - Repairs were made due to the 2016-2017 winter damage. The irrigation district is still working with FEMA on funding / reimbursement.
- **City of Pasco Fire Department – Dave Hare**

Station 4 is now open. A group of eight new recruits are currently in the probation phase. There will be an additional 6-9 hired in January 2018.
- **Franklin County Emergency Management – Sean Davis**

Justin Ratcliffe recently left FCEM and went to work for Lourdes. FCEM has a Program Coordinator position open and is taking applications. The cutoff date for accepting applications is 12/22/2017.
- **Oxarc – Samuel Sainz**

They currently have hazardous materials onsite (chlorine, sulfur dioxide, propane, butane) which are under the RMP (Risk Management Plan) Program.
- **DMCC – Beki Hammons**

The DMCC was recently notified regarding two incidents (transit bus/potato truck & a chemical leak at Columbia Crest) but did not have to activate. There were two patients seen.
- **SERC / FCFPD#3 – Mike Harris**
 - The SERC met 10/31/2017. They were reviewing their strategic plan due to lots of turnover. They had a presentation on reporting and response to EPA. There are changes in reporting of methane gas to EPA. Dairies will be reporting. Calculations are currently being worked on to determine reporting.
 - The SERC Conference location is TBD. The Hazmat Workshop is funded with the location TBD.
 - The HMEP grant funds come from fees by those who ship hazardous materials. Those fees are used for various things (Hazmat Conference / LEPC Conference – Travel). The HMEP grant monies are available to LEPC's for

training and exercises.

- There is not much happening at this time with the Emergency Management Council. Declarations for the winter floods 2016-2017 and wildland fires were declared. Mike stated they were in the waiting period for winter flooding to begin for the 2017-2018 year.

- **BNSF – Mike Sheehan**

Currently hazardous materials are stored near Mike's office.
