Franklin County LEPC Meeting Minutes March 6, 2018

Call to Order

Mylan Muhlestein brought the meeting to order at 10:00 a.m.

Introductions

Approval of Board Minutes from December 5, 2017

Motion to approve the minutes was made by Dave Hare. 2nd by Justin Ratcliffe. With all in favor, minutes were approved unanimously as written.

New Business

- 2017 Tier II reports: Sean Davis / Davey Hare
 - 1. Questions None
 - 2. LEPC address update/change Sean said some of the TIER II reports are not being sent to FCEM's current address of 1011 E. Ainsworth Street, Pasco, WA. He suggested entities look to see where their TIER II reports were sent and correct the address if necessary. Approximately 30% of TIER II reports currently received were sent electronically with the remainder being mailed (when mailed they need to be sent registered mail). Reports received electronically are sent an email confirmation from the Director.
 - 3. *Fire Department/District box* There is a box on the TIER II report that needs to be checked. This helps with information regarding what types of industry there is as well as the number of industries. Additionally it affects fees collected available to the Tri-County Hazmat team.
- Hazard Mitigation Plan (HMP) process: Sean Davis

Several LEPC members attended the HMP meeting held 03/06/2018. There were several suggestions for new projects to be added to the HMP. Some of these suggestions were due to the damage from the 2017-2018 winter snow/freeze/flood.

There are two HMP public comment meetings being held: 03/13/2018, at 6:30 pm at Franklin County Emergency Management and 03/14/2018, at 6:30 pm at Connell City Hall.

The Community Wildland Fire Protection Plan is being incorporated into the HMP.

leaks.

- 1. 11/07/17, Ruby Ridge Dairy Livestock air/atmosphere due to the EPA reporting requirements dairies are now reporting when livestock exceeds a certain number. This seems to affect the smell in the air.
- 2. 11/07/2017, Davidson Brothers Dairy Livestock air/atmosphere.
- 3. 11/08/2017, Coulee Flats Dairy Livestock air/atmosphere.
- 4. 11/08/2017, Harms fertilizer / sulfuric acid.
- 5. 11/09/2017, 5 D Farms Livestock air/atmosphere.
- 6. 12/08/2017, ???? Oil / Diesel (130 gal) State Duty Officer sent report with limited information.
- 7. 12/14/2017, LOMO Turbine Oil
- 8. 12/18/2017, DOE-RI radiological @ PFP outside demo zone this was due to the tunnel collapse. The hole has now been covered.
- 9. 12/22/2017, BNSF sodium chlorate (1 gal) residual on the train car
- 10.01/04/2018, LOMO hydraulic oil (100 gal)
- 11.01/11/2018, Freeze Pack Anhydrous Ammonia (5 Lbs.) NRC was notified and situation was remediated.
- 12.02/08/2018, Freeze Pack Anhydrous Ammonia (??? Lbs.) NRC was notified and situation was remediated.
- 13.02/12/2018, LOMO hydraulic oil (1 oz.)
- 14.02/18/2018, BNSF molten sulfur causing smell/odor (no release)

The Department of Ecology approved the first oil response plan from BNSF.
