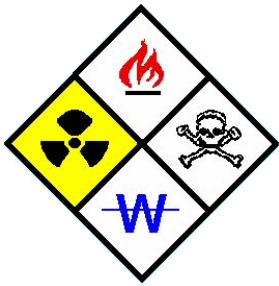

There were no major changes deemed necessary in 2018.

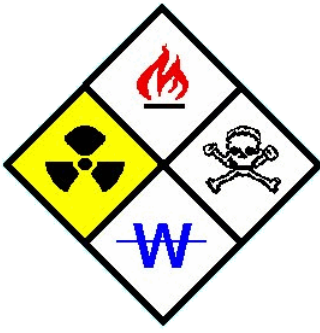

Franklin County LEPC Meeting Minutes September 4, 2018

Call to Order

Mylan Muhlestein brought the meeting to order at 10:00 a.m.

Introductions

Approval of Board Minutes from March 6, 2018

Motion to approve the minutes delayed.

New Business

- **2018 Washington State LEPC/Tribal Conference**
The Conference was attended by Mylan Muhlestein and Sean Davis
- **Reported Spills / Leaks: Deanna Davis / Sean Davis / Liz Jesse**
Remember to make your required calls to EPA, local fire, and the LEPC (FCEM)
Sean Davis stated EPA requests Tier 2 Reports as well as the report for notification of leaks.
 1. Benton County – No leaks of significance
 2. Franklin County – Incident with McGregor – Chief Harris responded
 3. Walla Walla County – Rail X – 25 Gallon Spill. No other spills of significance.
- **Changes in Washington State's dangerous waste rules – Angela Stenhouse**
 1. Business in Moses Lake is picking up regarding dangerous waste.
 2. There are proposed changes in the 2018 Dangerous Waste Regulations WAC173-303. The CRRC has been working on these changes for 13 years. Some rules will be more stringent while others will be less stringent. The Department of Ecology's stance has the same leaning. Handouts of WAC 173-303 were shared showing the suggested change and the reason for the change.
- **CSM Saunders Presentation - Delayed**

Unfinished Business

- **Hazard Mitigation Plan (HMP) Process**
 1. Benton County – They have been working on updating their plan. Currently they are in a comment period and hope to have finalized by the end of the year or early 2019.
 2. Franklin County – Their plan is at FEMA Region 10 for approval and then will be sent to the Jurisdictions for approval.
 3. Walla Walla County – Their plan was approved in 2017 with a few minor updates made since then.

Round Table

- **Walla Walla – Liz Jesse**
Getting ready to take part in the Nation Wide Test to be held on 09/20/2018 at 10:15 am.
- **Tidewater – John Sherman**
Tidewater will be holding a TTX in late October with a discharge of 20,000 gallons. There will be approximately 80m participants which will meet at the Red Lion in Pasco for the TTX.
- **FCEM / BCES – Sean Davis / Deanna Davis**
Benton County, Franklin County Dispatch, and Walla Walla 5 are merging into SECOMM on August 6, 2018 they should be up and running. For the Electronic Notification System (ETNS) FCEM and BCES are currently using CodeRED. BCES has recently used CodeRED for fires. Walla Walla is currently using Everbridge at their ETNS.
- **SERC – Chief Whalen**
The next meeting will be on 09/17/2017 at Northern Quest.

ESF 10 10 Hazardous Materials Response Plan – Liz Jesse

- Liz made some modest revisions. Added a record of changes and updated the fire chief's information and replaced College Place Evacuation Map with the 2008 version. Other modest changes were made as noted on page 14. Anyone having additional changes are to contact Liz no later than 09/15/2018. Changes made were not enough to go under review again.
