Remember to make your required calls to Washington State Duty Officer, National Response Center (NRC) and Local LEPC. – A call to 911 does not guarantee a notification to your LEPC.

Make sure to follow up within 30 days using the Emergency Release Follow Up Notification form.

A quick checklist sheet will be sent to LEPC members as a tool to use when reporting spills.

Benton County reports to Central Region Office (Yakima) 509-575-2490

Franklin County reports to Eastern Region Office (Spokane) 509-329-3400

EPCRA (Emergency Planning and Community Right-to-Know Act)

40 CFR Part 355.40

Section 304 - [Emergency Release Reporting](#)

There are no penalties for reporting a spill unnecessarily, but there may be significant penalties for not reporting one.

You must report a release of a hazardous substance that could expose anyone outside of your facility. This includes releases from motor vehicles, rolling stock, and aircraft.

Follow up Notification

Within **30 days**, you must send a follow-up notification to the SERC and your LEPC using the [Emergency Release Follow up Notification form](#).

Continuous releases

If you release a similar amount of hazardous substances consistently, you may fall under the continuous release reporting regulation ([40 CFR §302.8](#)). Find:

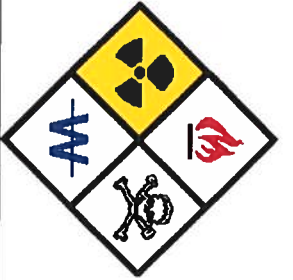
